- NO OTHER CHARGES SHALL BE APPLIED TO THE PETS VOUCHER
 - INCLUDING: BUT NOT LIMITED TO: PREGNANCIES, VACCINATIONS, MEDICAL NEEDS, EMERGENCIES, PAIN MED
- NO VERBAL COMMUNICATION REGARDING WHAT THE VOUCHER COVERS WITH ANY VETERINARIAN IS PERMITTED BY CLIENT
- THIS DOCUMENT MUST BE SIGNED BY CLIENT AND GIVEN TO VETERINARIAN AT TIME OF SERVICE
- WITHOUT THIS SIGNED DOCUMENT, NO SERVICE MAY BE PROVIDED
- P.E.T.S. & VETERINARIANS USING P.E.T.S. VOUCHERS RESERVE THE RIGHT TO REFUSE SERVICE TO ANY PAST, PRESENT OR FUTURE CLIENT FOR RUDENESS, NON-PAYMENT, PET ABANDONMENT, ABUSE OR "NO-SHOWS".
- MISSED APPOINTMENTS WITHOUT A PHONE CALL TO THE VETERINARIAN IN ADVANCE (NO SHOWS) WILL BE PERMITTED TO RESCHEDULE, HOWEVER THE COST WILL REVERT TO FULL PRICE.
- REPLACEMENT VOUCHERS DUE TO LOSS WILL BE SUPPLIED FOR A \$1 CHARGE.
